Cove

Our studio features a 25' x 29' cove with a 14' ceiling and grid.

Lights

Permanently installed cove lighting: 8 x 4 ft, 4 bank Kino Flo lights



Power

200 Amps dedicated studio power

Connected to cove, includes wardrobe rack, mirror, steamer

Includes window with view of cove, plus desk and chair

Crew Hire



Gear


Camera, lighting, grip packages, plus motion control gear

Parking Map

We have a parking lot next to our building that includes 10 designated parking spaces for productions and a loading area with a ramp. Free overflow parking is available along our driveway and on Encinal St. and Dubois St.



Studio Policies

Booking

In order to confirm and hold a reservation, a deposit of 25% of total rental fees will be due at the time of booking.

Cancellations

The booking deposit is refundable up to 8 days prior to the booking date. Any cancellations made less than 8 days prior to the booking date will be subject to cancellation fees.

Overtime

Hourly limits per booking day include total time on site. Any additional time needed beyond the specified limit will be subject to an overtime charge. See your studio rental contract for additional details.

Cleanliness

Before each rental, the studio is prepped and thoroughly cleaned and sanitized. We request it is returned in the same condition as when production arrived. This includes disposing of trash in designated bins. Oversize items must be removed from site by production's crew.

Smoking & Under the Influence

No smoking is allowed in the studio. No one who is under the influence of alcohol or illegal substances will be allowed in the studio.

Studio Surveillance

All persons and activity on site may be video recorded for security purposes.

Animals

No animals or pets are allowed on site without prior approval.

COVID Policies

Please follow current CDC and local guidelines during productions.

Cleaning

In addition to our routine cleaning, we have implemented extra sanitation of all high touch surfaces to ensure a clean space for your production. Production is responsible for routinely disinfecting high-touch surfaces while using studio.

Masks

Everyone who is inside the studio is required to wear a face covering, regardless of vaccination or any other circumstances. We will provide disposable masks to anyone who does not have their own.

Sanitation Stations

Hand sanitizer and disinfectant wipes are available at various locations inside the studio.

Crew Sizes

Please plan for your crew to remain in accordance with CDC and local guidelines, and inform us about the number of people who will be on site. We encourage limiting crew size as much as possible.

<u>Meals</u>

Consuming any food or drinks besides water is not allowed indoors. During meals, please ensure that you are outdoors and maintain a minimum of 6 feet from others.

Communication

It is the production's responsibility to communicate with Impact and with their crew regarding any crew or cast member that is exhibiting symptoms of COVID-19 or has tested positive.

Symptom Screening

Production is responsible for symptom screening prior to production.

Insurance Requirements

Renters must submit proof of insurance coverage prior to studio usage or gear release. Coverage must be on an ACORD "Certificate of Insurance" or "Evidence of Property Insurance" form endorsed by an A+ Insurance company.

Liability Insurance

- O Form of Coverage: All perils/all risk, including breakage on scheduled articles or professional camera floater policy including a full replacement cost endorsement.

- O Add Impact Creative, LLC as a "Loss Payee."

Workers' Compensation
